

DISCIPLINARY CODE FOR STUDENTS OF THE FACULTY OF PHYSICAL EDUCATION AND SPORT OF CHARLES UNIVERSITY

Under sections 27 (1) (b) and 33 (2) (e) of Act No. 111/1998 Sb., to regulate higher education institutions and to change and amend other laws (“the Higher Education Act”), as amended, the Academic Senate of the Faculty of Physical Education and Sport of Charles University has adopted the following Disciplinary Code for Students of the Faculty of Physical Education and Sport of Charles University as an internal regulation of the faculty.

Article 1 Introductory Provision

The Higher Education Act, the Administrative Procedure Code, The Constitution of Charles University, the Disciplinary Code for Students of Charles University, the Constitution of the Faculty of Physical Education and Sport, and this Code govern the infringements of disciplinary rules committed by students enrolled in the Faculty of Physical Education and Sport of Charles University (the “Faculty” and the “University”), the imposition of sanctions for such infringements, the disciplinary proceedings including appeal, and the details concerning the Disciplinary Board of the Faculty.

Article 2 Disciplinary Board

1. Any accusation of an infringement of disciplinary rules is considered by the Disciplinary Board of the Faculty (the “Board”).¹
2. Subject to the prior approval of the Academic Senate of the Faculty, the Dean dismisses and appoints members and alternate members of the Board from among the members of the academic community. The Board dismisses and elects the chairperson from among its members. Within 30 days of the appointment of the Board members, the Dean convenes the first meeting of the Board which has the election of the chairperson on its agenda.
3. The Board has six members. Half of them are students. Two members of the academic staff and two students are the alternate members.
4. The term of office of the Board members is two years, starting on the day of appointment of members and alternate members.
5. The Board membership is terminated:
 - a. upon expiry of the term of office;
 - b. before expiry of the term of office
 - i. when the membership in the academic community of the Faculty is terminated;
 - ii. on the date on which a statement in writing is delivered by which a member or an alternate member surrenders his/her membership or alternate membership on the Board.

6. The vacancy of a Board member which arose in accordance with paragraph 5 (a) and (b) is filled until the end of the term of office of the member whose post became vacant by an alternate member designated by the Dean.
7. If the Board receives an application to commence disciplinary proceedings about a Board member or an alternate member, such member or alternate member is excluded from consideration of the case.
8. The Board's rules of procedure are laid down in Article 5 of the Disciplinary Code for Students of Charles University.
9. If necessary, the Board can request an expert opinion from the members and non-members.

Article 3 **The Board's Rules of Procedure**

1. Disciplinary proceedings are held at the faculty where the student accused of an infringement of disciplinary rules (the "student") is enrolled. If the student is enrolled in more than one faculty, disciplinary proceedings concerning the same case may be held only at one of them.²
2. Disciplinary proceedings are commenced upon the Dean's proposal and are governed by Article 4 of the Disciplinary Code for Students of Charles University.
3. Consideration of the proposal and the Dean's decision are governed by Article 5 of the Disciplinary Code for Students of Charles University.
4. An appeal is governed by Article 6 of the Disciplinary Code for Students of Charles University, the Higher Education Act, and the Administrative Procedure Code.

Article 4 **Transitional and Final Provisions**

1. The Disciplinary Code for Students of the Faculty of Physical Education and Sport of Charles University in Prague from 15 March 2013 is hereby repealed.
2. Proceedings started before this Code became effective will be completed under this Code.
3. This Code was approved by the Academic Senate of the Faculty of Physical Education and Sport of Charles University on 14 June 2017.
4. This Code comes into force on the date of approval by the Academic Senate of Charles University.
5. This Code becomes effective on the first day of the calendar month following the date of coming into force.
